1. What do we process/use your personal data for? We will ask you for your name, email address, mobile phone number and club you are interested in for the purpose of letting you know about our current promotion.

2. Do you receive informative communications? If you authorise us, we can send you information messages, events, offers and news via email and SMS. You can withdraw your authorisation to receive these communications at any time by emailing dados@solinca.pt.

3. Who is responsible for processing your personal data? The person responsible for processing your personal data is the company that operates the club in respect of which you have expressed interest, and the companies operate the following clubs: Solinca Classic - all Solinca Classic clubs; UFM - Solinca Light Maia club; UFF - Solinca Light Foz club; UFE - Solinca Light Foz club; Solinca Light - all Solinca Light clubs other than those mentioned above. If you need to contact the societies responsible for the treatment, you can do so by e-mail dados@solinca.pt.

4. To whom are your personal data provided? Your personal data is only provided to entities whose collaboration is essential for the provision of the services you subscribe to, such as service providers, namely marketing or IT, as well as between the companies responsible for the processing and SC Fitness, S.A., entities belonging to the same economic group, for marketing purposes (promotional campaigns and communication to be carried out by those entities) associated with the Solinca and Element health clubs.

6. How long will your personal data be kept? Your personal data will be kept for as long as the purposes for which they are processed remain valid or until you withdraw your consent, where the processing of your personal data is carried out on that lawful basis.

7. Do you know what your rights are as a data subject? As a holder of personal data, you may exercise, at any time, the following rights: right of access, right of rectification, right of erasure, right to limitation of processing, right of portability and right to object to processing, by sending an e-mail to dados@solinca.pt.
